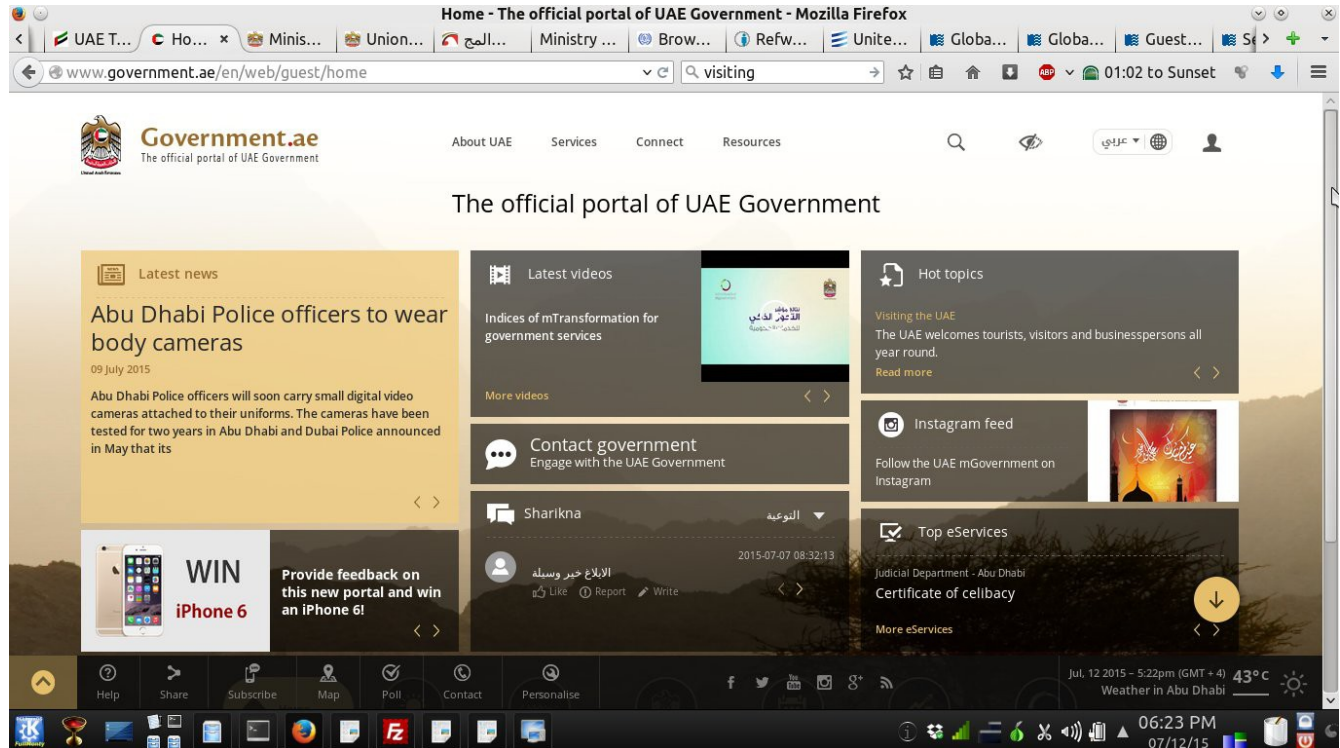

b. Other rights.

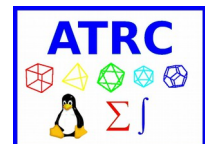
- d. Sections [1](#), [5](#), [6](#), [7](#), and [8](#) survive termination of this Public License.
